Beginning on January 1, 2012, ACT 32 takes effect which makes all Pennsylvania employers responsible for withholding local earned income taxes from employee paychecks. This is the 1% that is paid by all wage earners. Half of the taxes collected go to the Borough of Rosslyn Farms and the other half go to the Carlynton School District. We are asking for your assistance to ensure that the local earned income taxes deducted from your paychecks are received by the Borough of Rosslyn Farms and the Carlynton School District for the benefit of your family and the respective agencies.

To prepare for this change, all employees are required to file a Residency Certification Form

with their employer. The six digit political subdivision code (PSD Code) that you place on this form determines which municipality and school district receives your income tax payment. It is therefore essential that this code be entered correctly. The six digit Code for

the Borough of Rosslyn Farms and the Carlynton School District is 730403.

Please complete the remainder of Section 1, entitled "Employee Information Resident Location", and sign to certify that the information is correct in Section 3. Your employer is responsible for completing Section 2. An extra Residency Certification Form is included with

If you do not complete and submit this Residency Certification Form, there is a strong possibility that your taxes may be directed to another municipality and school district. Should this be the case, you will be responsible for paying the taxes to the Borough of Rosslyn Farms and Carlynton School District. In addition, you will be subject to penalties and interest. As a reminder, 4th quarter and 2011 year-end earned income submissions will still need to go to Tax Collector Ed Adams.
