IF THE BEHAVIOR DOESN'T IMPROVE THE OFFENDER WILL BE ASKED TO LEAVE THE POOL AREA FOR THE DAY. ONGOING BAD BEHAVIOR CAN RESULT IN FORFEITING YOUR POOL MEMBERSHIP.
